All primary and spousal members will be billed their 2024 Annual Dues to their member account on December 1st, 2023. Any members wishing to resign their membership must give written notice by December 15th, 2023.

Payment Plan: If you normally pay by the installment plan, the 1st payment will be due December 1st, 2023, and the 1st of each subsequent month for the 8 month installment period. All installment plan payments must end by July 1st, 2024.

All payments are cash, Visa/MasterCard/American Express/Debit or cheque only. Failure to meet instalments will result in a \$200.00 administration fee. Payment for either option must be received by Dec. 1/23. The payment options apply to A. Primary Member and B. Spousal Members only. All other fees are payable or will be applied to your account on Mar. 31/24.
