**Payment Plan:** If you normally pay by the installment plan, the 1st payment will be due December 1st, 2025, and the 1st of each subsequent month for the 8 month installment period. All installment plan payments must end by July 1st, 2026.

*All payments are cash, Visa/MasterCard/American Express/Debit or cheque only. Failure to meet instalments will result in a \$200.00 administration fee. Payment for either option must be received by Dec. 1/25. The payment options apply to A. Primary Member and B. Spousal Members only.
